

## Carroll County Republican Central Committee Questionnaire for General Assembly Candidates

### David Ellin, Republican Candidate, District 5

1. **Would you support a reduction in the cap on property tax assessments?**

Yes, I would support a reduction in the current cap on property tax assessments.

Carroll County currently has a 5% cap on property tax assessments.

As a point of reference, other jurisdictions' current cap on property tax assessments are: Anne Arundel County 2%; Baltimore City 4%; Baltimore County 4%; and PG County 1%.

2. **Would you support bringing all new taxes and tax rate increases for voter approval?**

Yes, I support bringing any new taxes or tax rate increases to the voters for approval.

3. **Would you support a Maryland Taxpayer Bill of Rights?**

Yes, I wholeheartedly support a Maryland Taxpayer Bill of Rights which is designed to educate and assist our citizens during tax filing. This would help keep our citizens informed of their rights when completing their tax forms.

4. **Would you support a citizen's right to carry firearms for personal protection?**

Yes, I support a citizen's right to carry firearms for personal protection. I also believe Maryland should be a Shall Issue state for concealed carry.

5. **Would you support taxpayer-funded benefits for illegal aliens?**

No, I do not support taxpayer-funded benefits for illegal aliens. Illegal means illegal and they should not be entitled to any taxpayer-funded benefits available to United States citizens.

6. **Should Maryland be a sanctuary state?**

Absolutely not. There are legal means to enter the United States and individuals seeking to live in the United States should follow our immigration laws. I do not support Sanctuary States. Illegal is illegal and those not here legally need to apply through the legal process to enter and stay in the United States.

7. **How do you plan on working with the BOE to do what is best for students and tax payers?**

I plan on working side-by-side with our Superintendent, Commissioners and the Board of Education to resolve any issues at the state level and fight to bring back Carroll County's rightful share of state education dollars to resolve our education fiscal deficit and better pay for our teachers, education resources and school safety issues.

8. **How would you rate Governor Hogan's performance?**

I approve of Governor Hogan's business-friendly attitude to bring more jobs to Maryland and his efforts to reduce Maryland taxes. However, I am disappointed in the Governor's failure to support Second Amendment rights and his recent signing of the Red Flag Bill 1302, which placed further limits on citizens' rights to own or keep firearms for self-protection.

**9. How do you plan on working with Governor Hogan to do what is best for Carroll County if you are both elected?**

As Delegate, my job is to represent the residents I am elected to serve, and fight for them and the County's best interests. As an attorney and small-business owner, I am an effective and persuasive negotiator, a strategic problem solver and a fierce advocate. **17. When and why did you become a Republican?**

I have been a Republican for over 19 years. I registered as a Republican in 1991, as soon as I was old enough to register to vote. I registered as a Republican because I admired President Ronald Reagan, who served as President until 1989. I thought President Reagan was a no-nonsense, charismatic leader who was able to get things done. He acted with integrity, was straightforward, well-liked, and he hated big government. He was responsible for the economic boom of the 1980's because of the bipartisan tax reform measures he signed into law that lowered individual and corporate tax rates to historic lows. Like President Reagan, I believe in a system of lower taxes and fewer government regulations. In 2006, I switched my party to Democrat because I was frustrated with changes in the law and their impact on injured citizens and their families.
